CERTIFICATE OF WATER RIGHT

**This Is to Certify, That OREGON STATE GAME COMMISSION
97208**

of **P. O. Box 3503, Portland, State of Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed drainageway and reservoir constructed under Application No. R-43121, Permit No. R-4919 a tributary of **Military Slough** for the purpose of irrigation of **27.2 acres and wildlife habitat**

under Permit No. **32220** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 12, 1966**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.25 cubic foot per second, being 0.23 c.f.s. from drainageway for irrigation and 0.02 c.f.s. from drainageway and reservoir for wildlife habitat**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 18, T. 36 S., R. 1 W., W. M., 3000 feet South and 1300 feet West from NE Corner, Section 18.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **$\frac{4}{8}$ acre feet per acre** for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
13.6 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
2.2 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
1.4 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 18
T. 36 S., R. 1 W., W. M.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
