CERTIFICATE OF WATER RIGHT

This Is to Certify, That **NORMA FISHER**

of **115 Hwy. 99 E, Junction City**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Three wells**

a tributary of **Willamette River** for the purpose of **irrigation of 84.7 acres**

under Permit No. **G-4065** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 13, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.05 cubic feet per second, being 0.19 c.f.s. from Well No. 1, 0.25 c.f.s. from Well No. 2 and 0.61 c.f.s. from Well No. 3**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **No. 1 & 2 - SW $\frac{1}{4}$ SW $\frac{1}{4}$; No. 3 - NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 29, T. 15 S., R. 4 W., W.M., No. 1 - 440 feet North and 20 feet East; No. 2 - 340 feet North and 1230 feet East; No. 3 - 2630 feet North and 1170 feet East from SW ***

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eighth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
