Route 2. Box 268, Vale , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Belnap Springs (9)

a tributary of Willow Creek supplemental irrigation of 36.0 acres for the purpose of

under Permit No. 35133 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 31, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.8 cubic foct per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the #1-NW WEL, 2, 3, 6, 4-SW NEL, 5, 6, 6 7-SE NEL, 8 & 9-NEt SEt, Section 1, T. 18 S., R. 44 E., W. M., #1-1310 feet South and 920 feet East, #2-1410 feet South and 1000 feet East, #3-1510 feet South and 1070 feet\*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

conform to such reasonable rotation system as may be ordered by the proper state officer.
