CERTIFICATE OF WATER RIGHT

This Is to Certify, That **HOWARD E. & ELGENE M. SMITH**
97443
of **P. O. Box 412, Glide**, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
~~Little River~~
a tributary of **North Umpqua River** for the purpose of
irrigation of 7.2 acres

under Permit No. **27792** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **January 15, 1962**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.09 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 2, T. 27 S., R. 3 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited to
a diversion of not to exceed **2 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during
the irrigation season of each year; and shall be further limited to the appropri-
ation of water during the period when the flow of the North Umpqua River is more
than **525 cubic feet per second** at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

**3.0 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
4.2 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 2
T. 27 S., R. 3 W., W. M.**

An order of the State Engineer entered May 7, 1974 canceled the right for the irri-
gation of 4.2 acres. This certificate is issued to confirm the remaining right and
supersedes the certificate heretofore issued to Ernest F. Roglitz and recorded at
page 31851, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
