that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.10 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW\$ SW\$, Section 35, Lot 1 (NE\$ NW\$), Section 26,
T. 38 S., R. 5 W., W. M., 680 feet North and 200 feet East from SW Corner, Section 35,
feet North and 150 feet West from SE Corner, Lot 1 (NE\$ NW\$), Section 26.

"he amount of water used for irrigation, together with the amount secured under any other ting for the same lands, shall be limited to one-eightieth of one cubic foot per second or its equivalent in case of rotation,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
