CERTIFICATE OF WATER RIGHT

CANCELED

This Is to Certify, That **ARTHUR ROSENBLAD**

of **Box 85, Scotts Mills**, State of **Oregon** **97375**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Butte Creek**

a tributary of **Pudding River** for the purpose of **irrigation of 11.5 acres**

under Permit No. **28228** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **July 31, 1962**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.14 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ SW $\frac{1}{4}$** , as projected within **S. Farrow DLC 44, Section 15, T. 6 S., R. 1 E., W. M., 1780 feet North and 2520 feet East from SW Corner, Lot 2 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 15.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**2.0 acres Lot 1 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
8.7 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.8 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
Both as projected within **M. Nowlen DLC 53**
Section 15
T. 6 S., R. 1 E., W. M.**

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered November 20, 1973, and together with the certificate recorded at page 41620, Volume 33, supersedes certificate of water right heretofore issued to Arthur Rosenblad and recorded at page 33473, Volume 25, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
