CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWARD E. MUELLER

of **Route 1, Box 287 A, Independence**, State of **Oregon**, **97351**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of **Rickreall Creek** for the purpose of irrigation of **53.1 acres**

under Permit No. **G-4103** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 25, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.66 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within **Scott DLC 65, Section 35, T. 7 S., R. 4 W., W. M., 1340 feet North and 1250 feet West from SW Corner, J. Shaw DLC 60.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres **NW $\frac{1}{4}$ NE $\frac{1}{4}$**
7.8 acres **SW $\frac{1}{4}$ NE $\frac{1}{4}$**
Both as projected within **Scott DLC 65**
4.9 acres **SW $\frac{1}{4}$ NE $\frac{1}{4}$**
As projected within **J. Shaw DLC 60**
0.1 acre **NE $\frac{1}{4}$ NW $\frac{1}{4}$**
As projected within **A. Shaw DLC 59**
24.0 acres **NE $\frac{1}{4}$ NW $\frac{1}{4}$**
1.3 acres **NW $\frac{1}{4}$ NW $\frac{1}{4}$**
0.2 acre **SW $\frac{1}{4}$ NW $\frac{1}{4}$**
12.6 acres **SE $\frac{1}{4}$ NW $\frac{1}{4}$**
All as projected within **Scott DLC 65**
Section 35
T. 7 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
