CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY L. DUNN

of Route 2, Box 226, Corvallis, State of Oregon, 97330, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaver Creek

a tributary of Muddy Creek for the purpose of irrigation of 39.0 acres

under Permit No. 32356 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 20, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Irwin DIC 43, Section 11, T. 13 S., R. 6 W., W. M., 2140 feet North and 350 feet East from NW Corner, Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$) Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.6 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
10.3 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
3.1 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
All as projected within Irwin DIC 43
2.8 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
8.3 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
Both as projected within Leneva DIC 45
3.9 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
As projected within Irwin DIC 43
Section 11
T. 13 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
