CERTIFICATE OF WATER RIGHT

This is to Certify, That **W. A. GREEN**

of **Haines**, State of **Oregon** has a right to the use of
the waters of **Rock Creek, Sand Creek, Willow Creek and Clear Creek, tributaries**
of **Powder River**
for the purpose of **the irrigation of 367 acres of land**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Baker County, and the said decree entered of record at Salem, in the Order
Record of the **STATE WATER BOARD** of the State of Oregon, in Volume **6**, at page **291**;
that the priority of the right thereby confirmed dates from **1892** for Tract No. 1: **1880** for
40 acres and **April 15, 1891** for **40 acres** in Tract No. 2: **1882** for **52 acres** and
1899 for **25 acres** in Tract No. 3 and **1872** for Tract No. 4

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed **1/40** of one cubic foot
per second per acre; and shall be subject to all other conditions and limitations
contained in said decree.

A description of the lands irrigated under such right, and to which the water is appur-
tenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from **Rock Creek**: **40 acres** in the Northwest quarter of Southeast
quarter; **40 acres** in the Southwest quarter of Southeast quarter and **40 acres** in the
Southeast quarter of Southwest quarter of Section Thirty: Township Seven South, Range
Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

Tract No. 2 from **Sand Creek**: **40 acres** in the Northeast quarter of Northeast
quarter and **40 acres** in the Northwest quarter of Northeast quarter of Section Thirty-one
Township Seven South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

Tract No. 3 from **Willow and Clear Creeks**: **19 acres** in the Southwest quarter of
Northwest quarter; **15.6 acres** in the Southeast quarter of Northwest quarter; **31 acres** in
the Northeast quarter of Southwest quarter; **8 acres** in the Northwest quarter of South-
west quarter and **3.4 acres** in the Southeast quarter of Southwest quarter of Section Two
Township Eight South, Range Thirty-eight East of Willamette Meridian, in Baker County,
Oregon.

Tract No. 4, from **Willow Creek**:
20 acres in the Southeast quarter of Southwest quarter; **30 acres**
in the Southwest quarter of Southeast quarter and **40 acres** in the Southeast quarter of
Southeast quarter of Section Five, Township Eight South, Range Thirty-nine East of
Willamette Meridian, in Baker County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place
of use herein described.
