CERTIFICATE OF WATER RIGHT

This Is to Certify, That McGILL BROTHERS (Leroy & Deroy)

of Route 1, Box 181, Turner , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Edgar Slough and reservoir constructed under Application No. R-46869, Permit No. R-5553

a tributary of Marion Creek (North Santiam River) for the purpose of supplemental irrigation of 68.6 acres, fish culture, and recreation

under Permit No. 34785 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 8, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.80 cubic foot per second, being 0.70 c.f.s. for irrigation and 0.10 c.f.s. for fish culture and recreation

or its equivalent in case of rotation, measured at the point of diversion from the start The point of diversion is located in the SEX NEX, as projected within McKinney DLC 55, Section 5, T. 10 S., R. 2 W., W. M., 1000 feet South and 1190 feet East from SE Corner, Wells DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; from Edgar Slough and reservoir constructed under Permit No. R-5553, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Recreation, Fish Culture, and 8.2 acres SWt NWt 7.3 acres NWt SWt Both as projected within McKinney DLC 55 Section 4

Recreation, Fish Culture, and 19.0 acres SEt NEt 25.7 acres NEt SEt 8.4 acres SEt SEt All as projected within McKinney DLC 55 Section 5
T. 10 S., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
