CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. CHESTER OAKES 97456
of **Route 1, Box 526, Monroe**, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Long Tom River and Fern Ridge Reservoir constructed under Permit No. R-1625

a tributary of **Willamette River** for the purpose of
supplemental irrigation of 117.0 acres

under Permit No. **33358** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **March 11, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
1.45 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **Res--NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 4, T. 17 S., R. 5 W., W. M.,
River--NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 23, T. 15 S., R. 5 W., W. M., River--2220 feet North and 930
feet East from SW Corner, Section 23.**

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre, or its equivalent for each acre irrigated from direct flow and shall be
further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each
acre irrigated during the irrigation season of each year from direct flow and
storage from reservoir constructed under Permit No. R-1625, provided further that
the right allowed herein shall be limited to any deficiency in the available supply
of any prior right existing for the same land and shall not exceed the limitation
allowed herein and is subject to the terms and conditions of contract No. 14-06-100-6205
between the Bureau of Reclamation and the applicant, a copy of which is* and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

8.8 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
