CERTIFICATE OF WATER RIGHT

This Is to Certify, That FLYNN BROTHERS

of **Plush**, State of **Oregon 97637**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **two wells**

a tributary of Sprague River for the purpose of irrigation of 178.5 acres and supplemental irrigation of 3.9 acres under Permit No. G-3969 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 29, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.28 cubic feet per second, being 1.45 c.f.s. from Mike's Well and 0.83 c.f.s. from Dice Crane Well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEX NEX, Section 34, T. 36 S., R. 12 E., W. M., and SEX NEX, Section 3, T. 37 S., R. 12 E., W. M., Mike's Well-380 feet South and 1320 feet West from NE Corner, Section 34, T. 36 S., R. 12 E., W. M., Dice Crane Well-2000 feet South and 450 feet West from NE Corner, Section 3, T. 37 S., R. 12 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
