CERTIFICATE OF WATER RIGHT

This Is to Certify, That FLYNN BROTHERS

of Plush, State of Oregon 97637, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Brown Creek and an unnamed stream a tributary of Sprague River for the purpose of irrigation of 233.5 acres

under Permit No. 33184 of the State Engineer and that said right to the use of said waters

under Permit No. 33184 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 29, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5-84 cubic feet per second, being 5-74 c-f-s- from Brown Creek and 0-10 c-f-s- from unnamed stream

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEX NEX, Section 35, SWX NWX, Section 36, T. 36 S., R. 12 E., W. M., Lot 1 (NEX NEX), Section 3, T. 37 S., R. 12 E., W. M., Brown Creek-1350 feet South and 270 feet West, 1780 feet South and 150 feet East, both from NW Corner, Section 36, T. 36 S., R. 12 E., W. M., unnamed stream-230 feet *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.
