CERTIFICATE OF WATER RIGHT

This Is to Certify, That **EUGENE CHEMICAL & RENDERING WORKS**
97446
of **P. O. Box 244, Harrisburg**, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Curtis Slough

a tributary of **Willamette River** for the purpose of
irrigation of 92.2 acres

under Permit No. **33102** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **December 12, 1967**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
1.15 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 27, T. 15 S., R. 4 W.,
W. M., 810 feet South and 2850 feet West from NE Corner, Section 27.**

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited to
**a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during
the irrigation season of each year;**

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

1.2 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
2.2 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
12.0 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
5.5 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
16.2 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
30.0 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$

All as projected within Clark DLC 45
Section 22

0.3 acre NE $\frac{1}{4}$ NE $\frac{1}{4}$
22.0 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
2.8 acres Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 27

T. 15 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
