This Is to Certify, That CLARENCE & MAXINE BECKER

of Route 1, Box 662, Monroe , State of Oregon 97456 , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of three wells

a tributary of Willamette River irrigation of 106.5 acres

for the purpose of

under Permit No. G-4757 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 3, 1969**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.33 cubic feet per second, being 0.39 c.f.s. from Well No. 2, 0.42 c.f.s. from Well No. 3, and 0.52 c.f.s. from Well No. 4

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the #2 - Mrk SEk, Section 22, #3 - NWk SWk, #4
NEK SWk, both as projected within Coffee DLC 68, Section 23, T. 14 S., R. 5 W.,

W. M., #2 - 800 feet South and 160 feet East, #3 - 570 feet South and 2370 feet East

#4 - 840 feet South and 3120 feet East, all from SW Corner, Oliver DLC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
