## CERTIFICATE OF WATER RIGHT

This is to Certify, That G. R. HODGIN AND JOHN ROHNER

of Baker, State of Oregon has a right to the use of

the waters of Powder River, tributary of Snake River, Pine Creek, Overflow and mining slough and Spring Creek, tributary of Powder River for the purpose of the irrigation of 319 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1882 for Tract No. 1; 1900 for Tract No. 2; 1865 for Tract No. 3; 1900 for Tract No. 4; 1866 for Tract No. 5 and 1883 for Tract No. 6.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Powder River: 30 acres in the Northwest quarter of Northeast quarter and 2 acres in the Southwest quarter of Northeast quarter of Section Twenty-four; 40 acres in the Southwest quarter of Northeast quarter and 25 acres in the Southeast quarter of Northwest quarter of Section Thirteen, Township Eight South, Range Thirty-nine East of Willamette Meridian.

Tract No. 2 from Powder River: 25 acres in the Northeast quarter of Southwest quarter and 5 acres in the Northwest quarter of Southeast quarter of Section Twenty-five, Township Eight South, Range Thirty-nine East of Willamette Meridian.

Tract No. 3 from Pine Creek: 20 acres in the Northeast quarter of Northwest quarter and 20 acres in the Northwest quarter of Northwest quarter of Section Twenty-six; Township Eight South, Range Thirty-nine East of Willamette Meridian.

Tract No. 4 from Overflow and mining slough: 4 acres in the Northwest quarter of Northeast quarter; 38 acres in the Southwest quarter of Northeast quarter of Section Twenty-four; 15 acres in the Southeast quarter of Northwest quarter of Section Thirteen; Township Eight South, Range Thirty-nine East of Willamette Meridian.

Tract No. 5 from Spring Creek: 35 acres in the Southwest quarter of Northwest quarter; 40 acres in the Southeast quarter of Northwest quarter of Section Twenty-six, Township Eight South, Range Thirty-nine East of Willamette Meridian.

Tract No. 6 from Spring Creek: 20 acres in the Northeast quarter of Northwest quarter of Section Twenty-six, Township Eight South, Range Thirty-nine East of Willamette Meridian,

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
