CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. J. STURTEVANT

of Pilot Rock, State of Oregon, has a right to the use of the waters of East Birch Creek

a tributary of Umatilla River for the purpose of the irrigation of 115.7 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 3, at page 127; that the priority of the right thereby confirmed dates from 1873 for 20 acres; 1882 for 50 acres and 1895 for 45.7 acres,

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.45 cubic feet per second, subject to the provisions of paragraph 33 of said decree.

Certificate of water right issued to A. J. Sturtevant and recorded at page 2627, Volume 3, State Record of Water Right Certificates confirms the right to the use of water for irrigation of 119.0 acres, domestic and stock use. Subsequently, the right to the use of water appurtenant to 3.3 acres was canceled by order of the State Engineer entered June 3, 1975. This certificate is issued to confirm the remaining right to the use of water for irrigation, domestic and stock use and supersedes the certificate heretofore issued to A. J. Sturtevant.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
