## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That FRANK L. NIMS

of Cove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Borkgren Craek, Mill Creek, Millard Branch, Thew Creek, Nims Creek, and Duncan Spring

a tributary of Grand Roule River for the purpose of irrigation of 16.1 acres, supplemental irrigation of 31.5 acres and domestic use for two families including irrigation of not to exceed one-half acre lawn and garden under Permit No. 31926 of the State Engineer, and that said right to the use of said waters has been perjected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 31, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.58 cubic foot per second, being 0.12 c.f.s. from Borkgren Cr., 0.23 c.f.s. from Mill Cr., 0.11 c.f.s. from Millard Branch, 0.05 c.f.s. from Thew Cr., 0.06 c.f.s. from Nims Cr., for irrigation and 0.01 c.f.s. from Duncan Spring for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NEX SWX, SWX SE, SEX SE, Section 22, SWX SWX,
Section 23, T. 3 S., R. 40 E., W. M., Nims Cr.-1630 feet North and 3200 feet West,

Duncan Spring-1230 feet North and 2570 feet West, Borkgren Cr.-730 feet North and 1670\*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
