CERTIFICATE OF WATER RIGHT

This Is to Certify, That Robert & STUART LANCEFIELD

of 3120 Mulberry Drive S., Salem, State of Oregon 97302, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Salt Creek and reservoir constructed under Permit No. R-4713

a tributary of South Yamhill River for the purpose of irrigation of 153-5 acres and supplemental irrigation of 2.6 acres under Permit No. 34745 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 20, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.32 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEX NW, as projected within Walling DLC 42, NEX SW, as projected within Watt DLC 73, Section 20, T. 5 S., R. 4 W., W. M., 1180 feet North and 1650 feet East, 670 feet South and 1980 feet East, both from SE Corner, Lancefield DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and further limited to the use of stored water only on the lands described as supplemental,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
