CERTIFICATE OF WATER RIGHT

This Is to Certify, That LOYD MORGAN

of **Elsie Route, Box 93, Seaside**, State of **Oregon**, **97138**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Osweg Creek**

a tributary of **Nehalem River** for the purpose of **domestic and commercial**

under Permit No. **34066** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 5, 1969**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.15 cubic foot per second, being 0.10 c.f.s. for domestic and 0.05 c.f.s. for commercial**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **#1-Lot 15 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 2, #2-Lot 16 (SE $\frac{1}{4}$ NE $\frac{1}{4}$) Section 3, T. 4 N., R. 7 W., W. M., #1-North 87 degrees 54 minutes 40 seconds East 5979 feet, #2-North 89 degrees 51 minutes 30 seconds East 4408 feet, both from***

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
