## CERTIFICATE OF WATER RIGHT

This Is to Certify, That Stiles enterprises, inc.

of P. O. Box 1868, Klamath Falls , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Williamson River

a tributary of Upper Klamath Lake irrigation of 114.3 acres and gravel washing

for the purpose of

under Permit No. 33333 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 28, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.36 cubic feet per second, being 2.86 c.f.s. for irrigation and 0.50 c.f.s. for gravel washing

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 22 (S½ NE½ SE½), Section 19, T. 35 S., R. 7 E., W. M., 390 feet North and 1540 feet West from SE Corner, Lot. 27 (S½ NW½ SW½), Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year. The use of water under this right is subject to the maintenance and use of adequate treatment facilities to remove the sediment before returning the water to the stream,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres Lot 16 (S½ SW½ NW½)
12.0 acres Lot 25 (N½ NW½ SW½)
19.6 acres Lot 27 (S½ NW½ SW½)
Gravel Washing and 12.3 acres Lot 34 (N½ SW½ SW½)
8.6 acres Lot 35 (S½ SW½ SW½)
4.8 acres Lot 33 (N½ SE½ SW½)
16.3 acres Lot 36 (S½ SE½ SW½)
19.5 acres Lot 32 (N½ SW½ SE½)

19.2 acres Lot 37 (St SWt SEt)

Section 20 T. 35 S., R. 7 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
