This Is to Certify, That DORA CURL THOMPSON

of 445 West Main, Sheridan , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River and two springs

a tributary of South Yamhill River for the purpose of domestic use for one family, stock, and irrigation of 7.1 acres

under Permit No. 36517 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 11, 1972 for irrigation and stock use and November 13, 1972 for domestic use

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second, being 0.005 c.f.s. from 2 springs for domestic use, 0.005 c.f.s. from Rogue River for stock and 0.09 c.f.s. from Rogue River for irrigation when available with any deficiency in the available supply for domestic use from*

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NWk SWk, Section 12, T. 6 S., R. 8 W., W. M.,

Spring 1-710 feet North and 760 feet East, Spring 2-250 feet North and 720 feet East,

River-40 feet North and 770 feet East, all from SW Corner, Wk NWk SWk, Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2; acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic, Stock, 6 5.0 acres Et NWt SWt
2.1 acres Wt NWt SWt
Section 12
T. 6 S., R. 8 W., W. M.

* springs to be made up by appropriation from Rogue River, provided the total quantity diverted from all sources for domestic use shall not exceed 0.005 cubic foot per second.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
