35790 of the State Engineer, and that said right to the use of said waters under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 24, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second, with any deficiency in the available supply from drainage to be made up by appropriation from Sevenmile Creek providing that the total quantity diverted from both sources shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Ditch-SE's NW's, NE's SW's, SE's SW's, Section 13, Cr.-SE's SE's, Section 11, T. 33 S., R. 6 E., W. M., Drainage collected in ditch between points 3320 feet North and 20 feet North, both from SW Corner, SEt SWt, *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one fiftieth of one cubic foot per second per acre, or its equivalent for each acre irriguted and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
