## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** DENNIS B. KNOWLES AND VERNON CAWLFIELD

of 65500 Gerking Mkt. Road, Bend, State of Oregon 97701, has  
a right to the use of the waters of Calamity Creek

a tributary of \_\_\_\_\_ for the purpose of  
irrigation of 85.7 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Malheur County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 8, at page 228; that the priority of the  
right thereby confirmed dates from 1886 for Tract No. 1; 1889 for Tract No. 2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per  
acre in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day  
period after June 1st, of each year, or 3 acre feet per acre during any season,  
diverted at a rate not to exceed one-twentieth of a cubic foot per second per  
acre;

The point of diversion is located in the NW¼ SW¼, Section 25; NE¼ SE¼, Section 26,  
Township 18 South, Range 33 East, W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as  
follows:

Tract No. 1  
18.2 acres SW¼ NE¼  
2.0 acres SW¼ NW¼  
18.0 acres SE¼ NW¼  
Section 25  
T. 18 S., R. 33 E., W.M.

Tract No. 2  
12.0 acres NE¼ SW¼  
2.0 acres NW¼ SW¼  
13.5 acres NE¼ SE¼  
20.0 acres NW¼ SE¼  
Section 25  
T. 18 S., R. 33 E., W.M.

Certificate of water right issued to Vernon Cawfield and recorded at page 6877,  
Volume 7, State Record of Water Right Certificates confirms the right to the use  
of water for irrigation of 95.2 acres. Subsequently, the right to the use of  
water appurtenant to 9.5 acres was canceled by order of the Water Resources Director  
entered October 17, 1975. This certificate is issued to confirm the remaining  
right to the use of water for irrigation and supersedes the certificate heretofore  
issued to Vernon Cawfield.

And said right shall be subject to all other conditions and limitations contained in said decree.  
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of  
use herein described.
