CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That FRANK L. SPAW

of Sisters State of Oregon has a right to the use of
the waters of SQUAW CREEK, a tributary of the Deschutes River, in Crook County,
Oregon,

for the purpose of irrigation during the irrigation season

and that said right has been confirmed by decree of the Circuit Court of the State of
Oregon for CROOK County, and the said decree entered of record at Salem,
in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at
page 120 ; that the priority of the right hereby confirmed dates from 1883;

that the amount of water to which such right is entitled and hereby confirmed for the
purpose aforesaid, is limited to an amount actually beneficially used for said pur-
pose , and shall not exceed 1.4 cubic feet per second.

A description of the lands irrigated under such right, and to which the water
hereby confirmed is appurtenant, or, if for other purposes, the place where such water
is put to beneficial use, is as follows:

14 acres in NE $\frac{1}{4}$ of SE $\frac{1}{4}$; 12 acres in NW $\frac{1}{4}$ of SE $\frac{1}{4}$; 23 acres in SW $\frac{1}{4}$ of SE $\frac{1}{4}$; and
21 acres in SE $\frac{1}{2}$ of SE $\frac{1}{4}$; Section Four (4), Township Fifteen (15) South Range Ten
(10) East of Willamette Meridian, in Crook County, Oregon.

This certificate is issued to correct an error in description of land in de-
cree, and certificate recorded in State Record of Water Right Certificates, Vol. 1,
page 259, and in Crook County Book of Water Right Certificates, Vol. 1, page 68,
being numbered 5449.

In accordance with the order entered on page 155 of the Record of Proceedings
of the State Water Board of Oregon, the water right erroneously made appurtenant to
the land described in such former certificate is hereby transferred to the land
above described, and the former certificate issued to E. P. Buchanan is hereby
declared to be of no force and effect.

The right to the use of the water aforesaid hereby confirmed is restricted to the
lands or place of use herein described.
