a tributary of South Santiam River irrigation of 59.8 acres

for the purpose of

under Permit No. G-4715 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot of water per second, being 0.50 c.f.s. from Well No. 1 and 0.25 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Well No. 1 - Lot 9 (SW NW), Section 23; Well No. 2 - SEZ NEX, as projected within Wassom DLC 49, Section 22, T. 11 S., R. 2 W., W. M., No. 1 - 1060 feet North and 460 feet East, No. 2 - 1180 feet North and 420 feet West from SE Corner, Wassom DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
