## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JOSEPH E. AND FRANCES L. BRONEC

of 8318 5. Highway 211, Canby , State of Oregon, 97013 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Bear Creek (Fudding River) irrigation of 66.4 acres

for the purpose of

under Permit No.G-3725 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 15, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.56 cubic foot per second, being 0.45 c.f.s. from Well #1 and 0.11 c.f.s. from Well #2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the #1-SW\ SE\, as projected within Adams DLC 44, Section 20; #2-NW\ NW\, as projected within Adams DLC 44, Section 29, T. 4 S., R. 1 E., W. M., Well #1-740 feet North and 40 feet West; Well #2-400 feet North and 2740 feet West; both from SE Corner, Adams DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tonne-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
