CERTIFICATE OF WATER RIGHT

This is to Certify, That MILES LEE,

of Baker, State of Oregon, has a right to the use of
the waters of Spring Creek, Waggie Creek, and Little Spring Creek, tributaries of
Powder River,
for the purpose of Irrigation of 401 acres of land,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Baker County, and the said decree entered of record at Salem, in the Order
Record of the STATE WATER BOARD of the State of Oregon, in Volume six, at page 291;
that the priority of the right thereby confirmed dates from 1865 for 60 acres; 1865 for 90
acres; 1864 for 60 acres; 1867 for 40 acres; 1865 for 61 acres and 1864 for
90 acres;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one
cubic foot per second per acre; and shall be subject to all other conditions and
limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

30 acres in the Southwest quarter of Southeast quarter, and 30 acres in the
Southeast quarter of Southeast quarter of Section Twenty-seven; 10 acres in the
Southeast quarter of Northeast quarter; 40 acres in the Northeast quarter of
Southeast quarter; 40 acres in the Northwest quarter of Southeast quarter; 30 acres
in the Southwest quarter of Northeast quarter; 30 acres in the Southeast quarter of
Northeast quarter; 20 acres in the Southwest quarter of Southeast quarter, and 20
acres in the Southeast quarter of Southeast quarter of Section Thirty-four;
40 acres in the Southwest quarter of Northeast quarter and 21 acres in the Southeast
quarter of Northeast quarter of Section Thirty-three; 40 acres in the Northeast
quarter of Northeast quarter; 40 acres in the Northwest quarter of Northeast quarter,
and 10 acres in the Southwest quarter of Northeast quarter of Section Thirty-four,
Township Eight South, Range Thirty-nine East of Willamette Meridian, in Baker County,
Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place
of use herein described.
