This Is to Certify, That FRED HARRIS

of B B Route, Box 216, Cottage Grove , State of Oregon, 97424 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Lane Creek and two reservoirs constructed under Applications No. R-45875 and No. R-45876, Permits No. R-5451 and No. R-5452 a tributary of Coast Fork Willamette River for the purpose of irrigation of 3.6 acres and fish culture

under Permit No. 34248 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 24, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic fact per second, being 0.05 c.f.s. for irrigation and 0.01 c.f.s. for fish culture

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, as projected within Lane DLC 42, Section 8, T. 21 S., R. 3 W., W. M., Harris Fish Pond-360 feet North and 500 feet West; Harris Reservoir-420 feet North and 230 feet West; both from 5t Corner, Section 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighticth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 24 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under permit No. R-5452;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> Lane Creek and Harris Pish Pond

Fish SEk SWk As projected within Lane DLC 42 Section 8 T. 21 S., R. 3 W., W. M.

Lane Creek and Harris Reservoir

3.5 acres SEt SWt 0.1 acre SWk SEk Both projected within Lane DLC 42 Section 8 T. 21 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
