CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES HASUIKE

of 15265 S. Bend Rd., Tigard , State of Oregon, 97223 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and Elwert Reservoir constructed under Application No. R-34149, Permit No. R-2459 a tributary of Chicken Creek for the purpose of irrigation of 36.6 acres

under Permit No. 26908 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1960 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SEL, Section 25, T. 2 S., R. 2 W., W. M., Diversion point located 450 feet North and 1350 feet West from the SE Corner, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2459,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.2 acres SWk SEk
4.6 acres SEk SEk

8.9 acres NEk NEk
9.9 acres NWk NEk

T. 2 S., R. 2 W., W. M.

Orders of the State Engineer entered April 3, 1969 and April 23, 1969 canceled the right to the use of water for the irrigation of 27.9 acres and approved a change in place of use of water for the irrigation of 12.0 acres. This cartificate is issued to confirm the remaining right and the change in place of use and supersedes certificate of water right heretofore issued to Herbert Elwert, recorded at Page 3312, Volume 25, State Record of Water Right Certificates. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
