has a right to the use of

the waters of Powder River, a tributary of Snake River and Elk Creek and Blue Canyo for the purpose of Powder River the irrigation of 597 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6 , at page 291 ; that the priority of the right thereby confirmed dates from 1871 for Tract No. 1: 1870 for 33 acres, 1894 for 81 acres; 1905 for 26 acres and 1908 for 17 acres in Tract No. 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one curic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Powder River: 40 acres in the Southeast quarter of Southwest unrter; 40 acres in the Southwest cuarter of Southeast quarter and 40 acres in the Southeast quarter of Southeast quarter of Section Eight: 40 acres in the Northeast quarter of Northeast quarter; 40 acres in the Northwest quarter of North east quarter; 40 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northeast quarter; 40 acres in the Northeast quarter of Southe st quarter; 40 acres in the Northwest quarter of Southeast quarter; 40 acres in the Southwest quarter of Southeast quarter and 40 acres in the Southeast quarter of Southeast quarter of Section Seventeen, Township Eight South, Range Forty East of Willamette Meridian, in Baker County, Oregon.

Tract No. 2 from Elk Creek and Blue Canyon: 32 acres in the Southwest quarter of Northeast quarter; 15 acres in the Southeast quarter of Northwest quarter; 25 acres in the Northeast quarter of Southeast quarter; 20 acres in the Northwest quarter of Southeast quarter and 40 acres in the Southeast quarter of Southeast quarter of Section Twenty-three and 25 acres in the Southwest quarter of Southwest quarter of Section Twenty-four, Township Ten South, Range Thirty-nine East of Willamette Meridian, in Baker County, Orggon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
