CERTIFICATE OF WATER RIGHT

This is to Certify, That S. C. MANN

of Baker, State of Oregon has a right to the use of
the waters of Wolf Creek and Springs in SW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 18, T 6 S.R. 39 E.W.M.,
tributary of Powder River and Powder River, tributary of Snake River
for the purpose of the irrigation of 516 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Baker County, and the said decree entered of record at Salem, in the Order
Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291;
that the priority of the right thereby confirmed dates from 1870 for Tract No. 1; 1863
for 200 acres and 1908 for 35 acres in Tract No. 2; 1863 for Tract No. 3; 1877
for Tract No. 4 and 1892 for Tract No. 5 and March 28, 1869 for Tract No. 6

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot
per second per acre; and shall be subject to all other conditions and limitations
contained in said decree

A description of the lands irrigated under such right, and to which the water is appurtenant
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Wolf Creek: 40 acres in the Northeast quarter of Northeast
quarter; 40 acres in the Southeast quarter of Northeast quarter and 30 acres in the
Northeast quarter of Southeast quarter of Section Seventeen:

Tract No. 2 from Wolf Creek: 40 acres in the Northeast quarter of Northwest
quarter; 20 acres in the Northwest quarter of Northwest quarter; 15 acres in the
Southwest quarter of Northwest quarter; 40 acres in the Southwest quarter of
Northeast quarter; 40 acres in the Northeast quarter of Southwest quarter; 20
acres in the Northwest quarter of Southwest quarter; 20 acres in the Southwest
quarter of Southwest quarter and 40 acres in the Southeast quarter of Southwest
quarter of Section Seven:

Tract No. 3 from Wolf Creek: 40 acres in the Southwest quarter of Northwest
quarter and 40 acres in the Southeast quarter of Northwest quarter of Section
Eighteen:

Tract No. 4 from Wolf Creek: 40 acres in the Southwest quarter of South-
east quarter and 10 acres in the Northeast quarter of Southeast quarter of
Section Seventeen:

Tract No. 5 from Springs: 40 acres in the Southeast quarter of Southeast
quarter of Section Seventeen:

All of the above land being in Township Six South, Range Thirty-nine East
of Willamette Meridian, in Baker and Union Counties, Oregon.

Tract No. 6 from Powder River: 1 acre being portion of Block A, McCrary's
Addition to Baker, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place
of use herein described.
