## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WIRTH FARMS

of Rt. 1 Box 13, Shedd , State of Oregon, 97377 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Calapooia River

a tributary of Willamette River irrigation of 253.2 acres

for the purpose of

under Permit No. 33115 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 28, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.7 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $\#2-SE_4$  NE $^14$ , as projected within Kendall DLC 48, Section 30;  $\#3-NE^14$  NW $^14$ , as projected within Thompson DLC 47, Section 32, T. 12 S., R. 3 W., W. M., #2-820 feet South and 960 feet West from the NE Corner, Kendall DLC 48; #3-910 feet South and 1030 feet West from the N $^14$  Corner, Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
