a tributary of Tualatin River

for the purpose of

irrigation of 1.6 acres and supplemental irrigation of 203.1 acres

and that said right to the use of said waters has been perfected in under Permit No. 32670 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

April 20, 1967 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 97.9 acre feat stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NIL NEL, as projected within Holbrook DLC 62, Section 17, T. 1 S., R. 2 W., W. M., 580 feet South and 1480 feet West from the NE Corner, Section 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____of one cubic foot ner second Jer_acre, a diversion of 24 acre feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land,
