CERTIFICATE OF WATER RIGHT

This Is to Certify, That **DAMASCUS WATER DISTRICT**

of **19750 SE Damascus Lane, Boring**, State of **Oregon, 97009**, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of **Damascus Water District Well No. 4**

a tributary of **Rock Creek (Clackamas River)** for the purpose of **municipal use**

under Permit No. **G-5162** and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 22, 1972**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.61 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE¹ SE¹, Section 32, T. 1 S., R. 3 E., W. M., 2575 feet North and 450 feet West from the SE Corner, Section 32.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~-----~~ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
