a tributary of Umpqua River irrigation of 121.4 acres

for the purpose of

under Permit No. 27985 and that said r^i ght to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.25 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW% NE%, as projected within Way DLC 51, Section 4,
T. 27 S., R. 6 W., W. M., 1340 feet North and 680 feet West from the SW Corner,
Way DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the South Umpqua River is 60 c.f.s. or more at its mouth;
