and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 4 , at page 1 ; that the priority of the
right thereby confirmed dates from 1876

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 2.46 cubic feet per
second.

The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 5, T. 40 S., R. 3 W., W. M.,
SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 15, T. 39 S., R. 3 W., W. M., Comstock Ditch located; 1000
feet North and 1190 feet East from the SW Corner, Section 5, Pump: 275 feet
North and 1990 feet East from the W $\frac{1}{2}$ Corner, Section 15.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

An order of the State Engineer entered July 8, 1974 approved a change in
point of diversion for the irrigation of 5.0 acres. This certificate is
issued to confirm the remaining right not involved in the change and
supersedes the certificate heretofore issued to Leslie C. and Thelma I. Schneider
and Fred L. and Nancy R. Straube recorded at Page 40385, Volume 32, State
Record of Water Right Certificates.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described, and is subject to the existing minimum flow policies established
by the Water Policy Review Board.
