## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

CARTEE AND NINA L. WOOD

of P.O. Box 716, Libby, State of Montana, 59923, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean  
irrigation of 0.9 acre

for the purpose of

under Permit No. 26969 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 22, 1960 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 11, T. 36 S., R. 3 W., W. M., Diversion point located 20 feet East and 80 feet South from the W $\frac{1}{4}$  Corner of Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre Lot 5 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ )  
0.3 acre Lot 5 (NE $\frac{1}{4}$  SE $\frac{1}{4}$ )  
Section 10

0.1 acre Lot 5 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 11  
T. 36 S., R. 3 W., W. M.

An order of the Water Resources Director entered January 30, 1976 approved a change in point of diversion for the irrigation of 1.2 acres. This certificate is issued to confirm the remaining right not involved in the change and supersedes the certificate heretofore issued to Cartee and Nina L. Wood recorded at Page 34357, Volume 26, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
