## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

FIDEL BROTHERS

of R. 2 Box 106, Yamhill , State of Oregon, 97148 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Turner Creek and reservoir constructed under Application No. R-25390, Permit No. R-1197

a tributary of Yamhill River irrigation of 7.5 acres

for the purpose of

under Permit No. 19292 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot pex second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE's NE's, as projected within Perkins DLC 55, Section 31, T. 2 S., R. 4 W., W. M., 50 feet North and 1420 feet West from the SE Corner, Perkins DLC 55.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; from direct flow and storage from reservoir constructed under Permit No. R-1197,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
