or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE's SE's, Section 33, T. 24 S., R. 11 W., W. N., 912 feet North and 90 feet East from the SW Corner, SE, SE, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second er acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
