CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PAUL J. CHOBAN

of Star Route, Box 285, Forest Grove, State of Oregon, 97116, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Gales Creek, unpamed stream, and reservoir constructed under Permit No. R-4907

a tributary of Tualatin River for the purpose of irrigation of 6.0 acres and supplemental irrigation of 9.3 acres

under Permit No. 35154 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 20, 1970 that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second, being 0.12 c.f.s. from Gales Creek for supplemental irrigation and 0.08 c.f.s. from the unnamed stream and reservoir for primary irrigation with any deficiency in the available supply from the unnamed stream to or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW4 SW4, Section 16; SW4 SE4, Section 17; both projected within Shepherd DLC 62, T. 1 N., R. 4 W., W. M., Unnamed Stream-2150 feet South and 280 feet West; Gales Creek-3180 feet South and 3110 feet West; both from the NE Corner, Shepherd DLC 62, Section 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

* be made up by appropriation from Gales Creek provided that the total quantity from both sources shall not exceed 0.08 cubic foot per second for irrigation.

conform to such reasonable rotation system as may be ordered by the proper state officer.
