CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES L. HUGHES

of Star Route, Box 1054, Winston, State of Oregon, 97496, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River for the purpose of irrigating 6.55 acres

under Permit No. 29393 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 5, 1964 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Phipps DLC 37, Section 4, T. 29 S., R. 6 W., W. M., Diversion point located 410 feet South and 1325 feet East from the N $\frac{1}{2}$ Corner of Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the South Umpqua River is more than 60 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.05 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
0.5 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
Both projected within Phipps DLC 37
Section 4
T. 29 S., R. 6 W., W. M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at Page 34870, Volume 26, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on January 14, 1976 approving transfer applications No. T-3232 and T-3281.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
