CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRANCIS M. HORN

of P.O. Box 274, Saginaw, State of Oregon, 97472, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coast Fork Willamette River

a tributary of Willamette River for the purpose of irrigation of 121.0 acres

under Permit No. 9996 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 22, 1930 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.51 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$, SW $\frac{1}{4}$, Section 10; NE $\frac{1}{4}$, NW $\frac{1}{4}$, Section 15, T. 20 S., R. 3 W., W. M., 370 feet South and 2170 feet West of the NW Corner of Vandervert DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use of water from the Coast Fork of the Willamette River approved by an order of the State Engineer entered on January 30, 1973 and describes that portion of the water right confirmed by the prior certificate recorded at Page 11298, Volume 10, State Record of Water Right Certificates, NOT modified by the provisions of the same order of the State Engineer entered on January 30, 1973, approving transfer application No. T-2741.

The issuance of this superseding certificate does not confirm the status of the remaining water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
