CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DEPARTMENT OF FISH AND WILDLIFE

of P.O. Box 3503, Portland , State of Oregon, 97208 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rock Creek, Spring Creek, and an unnamed stream

for the purpose of Salmon Hatchery, domestic use for one family, and maintenance of Siletz River Hatchery ponds constructed under Application No. R-25799, Permit No. R-2006 under Permit No. 24825 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Rock Creek & unnamed stream-March 28, 1951; Spring Creek-December 20, 1952; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 11.02 cubic feet per second, being 9.0 c.f.s. from Rock Creek; 0.01 c.f.s. from unnamed stream; 2.0 c.f.s. from Spring Creek for operation of salmon hatchery; and 0.01 c.f.s. from Spring Creek for domestic use,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW% NE%; SW% NE%; SE% NE%, Section 7, T. 10 S., R. 8 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at Page 30887, Volume 22, State Record of Water Right Certificates, NGT modified by the provisions of an order of the Water Resources Director entered on July 21, 1976, approving transfer application No. 3396.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
