for the purpose of

under Permit No. G-732 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 23, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE's SE's, as projected within W. Munkers DLC 51, Section 8, T. 7 S., R. 2 W., W. H., Well is N. 150 14' W. 2856 feet from the SE Corner of W. Munkers DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

The legal description of the property on which the well is located and the water is used is as follows:

Beginning at a point 13.56 chs. North 260 East and 26.565 chs. North 640 151 West of the Southeast corner of the W. R. Munkers DLC 51 in T. 7 S., R. 2 W., W. M., in Marion County, Oregon; thence North 26° East 22.63 chs.; thence North 64° 15' West 328 feet; thence South 26° West 22.60 chs.; thence South 640 15' East 328 feet to place of beginning.

This certificate describes that portion of the water right-confirmed by the prior certificate recorded at Page 28920, Volume 21, State Record of Water Right Certificates, NOT cancaled by the provisions of an order of the State Engineer entered on June 30, 1975.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
