the waters of Houghton Creek and Tucker Creek, tributaries of Powder River, and Powder River, tributary of Snake River for the purpose of the irrigation of 482.5 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Baker County, and the said decree entered of record at Salem, in the Order
Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291;
that the priority of the right thereby confirmed dates from 1876 for Tract No. 1; 1888
for Tract No. 2 and 1876 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Houghton Creek: 20 acres in the Southeast quarter of Southeast quarter of Section Seven and 10 acres in the Northeast quarter of Northeast quarter of Section Eighteen:

Tract No. 2 from Powder River: 39.5 acres in the Southwest quarter of Southwest quarter and 19 acres in the Southwest quarter of Southwest quarter of Section <u>Eight</u>: 40 acres in the Southwest quarter of Northwest quarter; 29 acres in the Northwest quarter of Northwest quarter; 40 acres in the Northwest quarter; 40 acres in the Northwest quarter; 40 acres in the Southeast quarter of Northwest quarter; 40 acres in the Northwest quarter of Southeast quarter of Southeast quarter of Southeast quarter of Southeast quarter of Section Seventeen:

Tract No. 3 from Ticker Creek: 40 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northwest quarter; 15 acres in the Northeast quarter of Southeast cuarter and 30 acres in the Northwest quarter of Southeast quarter of Section Seventeen: (This land is also irrigated from Powder River and included above for supplementary supply)

All of the above lands are located in Township Eight South, Range Forty-two East of Willamette Meridian, in Baker County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
