CERTIFICATE OF WATER RIGHT

This is to Certify, That R. R. PALMER & H. E. DENHAM

of Baker, State of Oregon has a right to the use of

the waters of Sutton Creek and West Sutton Creek, tributary of Powder River and Powder River, tributary of Snake River for the purpose of the irrigation of 385.6 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1873 for 100.6 acres; 1886 for 21 acres; 1907 for 24 acres and 1872 for 240 acres

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

23 acres in the Southwest quarter of Northeast quarter; 19 acres in the Northeast quarter of Southeast quarter; 23 acres in the Northwest quarter of Southeast quarter and 35.6 acres in the Southeast quarter of Southeast quarter of Section Twelve: 12 acres in the Southeast quarter of Northeast quarter; 28 acres in the Northeast quarter of Northeast quarter and 5 acres in the Northwest quarter of Northeast quarter of Section Thirteen: Township Ten South, Range Forty East of Willamette Meridian, in Baker County, Oregon. (Supplementary supply from East Sutton Creek or Ebell Creek under priority date of 1906) 40 acres in the Southeast quarter of Northwest quarter; 40 acres in the Northeast quarter of Northwest quarter; 40 acres in the Northwest quarter of Northwest quarter and 40 acres in the Southwest quarter of Northwest quarter of Section Six, Township Nine South, Range Forty; 40 acres in the Northeast quarter of Northeast quarter and 40 acres in the Southeast quarter of Northeast quarter of Section One, Township Nine South, Range Thirty-nine, all East of Willamette Meridian, in Baker County, Oregon

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
