CERTIFICATE OF WATER RIGHT

This Is to Certify, That

J. E. AND V. HANNAH

of Rt. 1 Box 566, Eagle Point , State of Oregon, 97524 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 17.1 acres

for the purpose of

under Permit No. 17627 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

March 24, 1947 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (SEK NEX); NEX SEX, Section 5, T. 35 S., R. 1 W., W. M., 475 feet North and 975 feet West; 175 feet South and 1425 feet West, both from the Ex Corner of Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year, from April 2 to October 31,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.3 acres Lot 6 (SE's NE's)
1.7 acres NWs SE's
9.1 acres SWs NE's
Section 5
T. 35 S., R. 1 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered February 13, 1970 as well as to describe that portion of the water right confirmed by the prior certificate recorded at Page 22460, Volume 16, State Record of Water Right Certificates, NOT modified by the provisions of the same order which approved transfer application No. H-199. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
