## CERTIFICATE OF WATER RIGHT

This is to Certify, That F. A. PHILLIPS

of Baker, State of Oregon has a right to the use of

the waters of Balm Creek, tributary of Powder River, and Powder River, a tributary of Snake River

for the purpose of the irrigation of 1126.2 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6 at page 291 that the priority of the right thereby confirmed dates from 1879 for 100 acres; 1893 for 50 ac 1905 for 61.5 acres; 1880 for 336 acres; 1888 for 95 acres, April 19, 1898 for 378.7 acres and 1901 for 105 acres

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed  $\frac{1}{40}$  of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

39 acres in the Northwest quarter of Southwest quarter; 30 acres in the Southwest quarter of Southwest quarter; 30 acres in the Southeast quarter of Southwest quarter; 36 acres in the Southwest quarter of Southeast quarter and 33 acres in the Southeast quarter of Southeast quarter of Section Twenty-five: 39.5 acres in the Northeast quarter of Southeast quarter and 4 acres in the Southeast quarter of Southeast quarter of Section Twenty-six, Township Eight South, Range Forty-two East of Willamette Meridian, in Baker County, Oregon. (Note: Claimant has supplementary supply from Powder River through Cranston ditch for 105 acres thereunder, with a priority date of 1901)

40 acres in the Northeast quarter of Northeast quarter; 31 acres in the Northeast quarter of Northeast quarter; 19 acres in the Southwest quarter of Northeast quarter; 39 acres in the Southeast quarter of Northeast quarter of Section Thirteen, Township Eight South, Range Forty-one East of Willamette Meridian.

29 acres in the Southwest quarter of Northwest quarter and 1 acre in the Northwest quarter of Southwest quarter of Section Eighteen: 37.5 acres in the Northeast quarter of Northeast quarter; 29 acres in the Northwest quarter of Northeast quarter and 8.5 acres in the Southeast quarter of Northeast quarter of Section Nineteen: 39 acres in the Southwest quarter of Northwest quarter of Section Twenty: 39 acres in the Northeast quarter of Southwest quarter; 40 acres in the Northwest quarter of Southwest quarter; 39 acres in the Southwest quarter of Southwest quarter of Section Twenty-six: 8 acres in the Southwest quarter of Southwest quarter; 8 acres in the Southeast quarter of Southwest quarter and 2 acres in the Southwest quarter of Southeast quarter of Section Twenty-five: 35 acres in the Southeast quarter of Southeast quarter of Section Twenty-six: 40 acres in the Northeast quarter of Northeast quarter; 39 acres in the Northwest quarter of Northeast quarter; 32 acres in the Northeast quarter of Northwest quarter and 32.5 acres in the Northwest quarter of Northwest quarter of Section Thirty-six, Township Eight South, Range Forty-two East of Willamette Meridian.

20 acres in the Southwest quarter of Northeast quarter; 15 acres in the Southeast quarter of Northeast quarter; 4 acres in the Northeast quarter of Northwest quarter; 23.5 acres in the Northwest quarter of Northwest quarter; 45.7 acres in the Southwest quarter of Northwest quarter; 40 acres in the Southeast quarter of Northwest quarter and 40 acres in the Northeast quarter of Southeast quarter of Section Thirty-one: 14 acres in the Northwest quarter of Northeast quarter; 17 acres in the Southwest quarter of Northeast quarter; 20 acres in the Southeast quarter of Northeast quarter; 28 acres in the Northeast quarter of Northwest quarter and 20 acres in the Northwest quarter of Northwest quarter of Section Thirty-one, Township Eight South, Range Forty-three East of Willamette Meridian, All in Baker County, Oregon.

*The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.*
