CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ROBERT H. HILL**

of Rt. 3 Box 346, Newberg, State of Oregon, 97132, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed spring

a tributary of Tualatin River for the purpose of irrigation of 11.1 acres and domestic use for one family

under Permit No. 34341 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 23, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second, being 0.14 c.f.s. for irrigation and 0.01 c.f.s. for domestic use

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Ayers DLC 50, Section 21, T. 2 S., R. 3 W., W. M., 3020 feet North and 480 feet West from the SE Corner of Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre Lot 6 (NE $\frac{1}{4}$ SE $\frac{1}{4}$)
 Domestic Use and 3.4 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
 0.7 acre NW $\frac{1}{4}$ SE $\frac{1}{4}$
 0.3 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
 2.5 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
 All projected within Brisbane DLC 53
 4.0 acres Lot 7 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
 Section 21
 T. 2 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
